 - c. 03/24/15: ED met with Harry Grove on a revised model of the entrance sign at the Rancho Grande Industrial Park. The revised model is such smaller in size and only reflects "Rancho Grande Industrial Park a project of the FEDC and the address. No company names are involved since there have been no requests for individual companies' sign recognition. The revised sign will cost much less than the previous model and require little to no maintenance.
 - d. 03/24/15: ED contacted Richard Nicholls, Regional President of New Haven Assisted Living and Memory Care Centers concerning their decision to move forward to closing as their current feasibility period expired on 03/24/15. Richard responded that they "were in" and the title search is being update for a closing with the next 30 days.
 - e. The March 11th Alliance Breakfast meeting was held on March 25th with the guest speaker, Ben Garza, MBA, Sr. Business Advisor, SBDC UTSA in attendance. Ben has been advising new and existing business owners, in the Floresville area, since shortly after my arrival on October 1, 2013. The FEDC is requesting Ben host a public business

seminar (s) on "Success Planning for Your Business" to highlight SBDC many business assistance services available, at no costs, to business owners.

Retail Proposals:

• The three retail proposals bring a very specific service that includes focused relationships with retailers and developers and an understanding of what it takes for those entities to be successful in varied market types. Due to their daily interaction with these companies, they bring instant credibility, focus, and expertise to the retail development process. This track-record comes from "doing good deals" and gaining the retail community's professional respect. These retail proposals offer a significant value (and cost savings) with their representation of the FEDC and the City at not only ICSC RECON 2015 (Las Vegas) (May 17-20) but also at over a dozen other industry trade shows. The chosen retail provider will be setting appointments with selected retailers doing business in towns the size and makeup of Floresville. Also, meeting retailers on behalf of the FEDC/City at the ICSC regional and national conferences, along with the ongoing recruitment efforts taking place independent of trade shows (outbound calls, portfolio reviews, etc.) demonstrating to the retail community that they NEED to be in Floresville.

Because we want strong representation at the May 17-20 ICSC RECON 2015, Las Vegas tradeshow, approval of one retail service provider is being requested. FEDC will be paying 100% of the Retail Service Provider's fee because the City has no available money. The City Manager has agreed that the City will pay 100% of the service fees from Graphitiks Advertising, Website Design and professional marketing materials for both the City and FEDC from hotel/motel tax revenue.

Fees, during a 3 year contract term, are as follows:

- <u>Retail Strategies:</u> Year 1: \$36,000; Year 2: \$36,000; Year 3: \$36,000= \$108,000
- Retail Coach: Year 1: \$30,000; Year 2: \$15,000; Year 3: \$15,000 = \$60,000
- <u>Buxton:</u> Year 1: \$50,000; Year 2: \$50,000; Year 3: \$50,000 = \$150,000
