  - b) Personnel: Jason Talley is in Austin on business, tonight and requested an excused absence.
- 4. Executive Officer's Report:
  - a) Marketing letters, with a copy of the traffic count study, have been sent to 40-50 restaurants.
  - b) FELPS has received approval from TXDOT to bring 3 phase electrical across FM 537 to the Udelhoven site.
  - c) The contract on Lot 4, Veterans Business Park, has been fully executed and earnest money receipted by Murray Title on May 2, 2014 which was the first day of a 90 day feasibility period (expires August 1, 2014).
  - d) Executive Director is working with Harry Grove on the design of a FEDC marketing brochure.
  - e) Façade grant, to Arcadia Theater, is progressing with exterior painting completed. Next will be a new, red "Arcadia" vertical sign and a back-lit marquee for multiple showings information. City Cleaners approached me for a Façade grant application after Arcadia's exterior painting was started.
  - f) The Construction Extension Agreement between Eric and Lisa Rodriguez and the FEDC has been fully executed by all parties and is now in effect.
  - g) Executive Director is scheduled to attend a 2 day Texas Rural Challenge Economic Development Conference in Waco, Texas on June 19-20.
  - h) I have requested the County, through Paul Pfeil, grade the roads in the Industrial Park. An Interlocal Agreement is required and the County Judge contacted me about the terms and a decision to proceed. FEDC will pay the County \$50/hr to grade all roads (I had an outside contractor bid \$18,000) and I approved moving forward with the Agreement.

## **New Business:**

5. Discussion and Possible Action Item:

Seek authority from Board for Executive Director to execute legal documents, including contracts and warranty deeds on behalf of the FEDC.

6. Discussion and Possible Action Item:

Seek approval from Board to grant a 1 year contract to Barry Morrison, for mowing/shredding all FEDC owned real property at time intervals decided by FEDC Executive Director. The Morrison bid was \$42/ac. versus \$50/ac. from James Freasier, Jr. Ranch. Barry Morrison's bid of \$42/ac. is recommended by E.D.

7. Discussion and Possible Action Item:

To complete the "trade" between Hammer and the FEDC for road drainage and paving it has been necessary to hire Title Express to run a mineral search on the two-30.93 ac tracts owned by Hammer Isolation and Hammer Exploration, to verify, in writing, that the FEDC owns 100% of the minerals under these 2 tracts. Cost estimates range from \$2400 to \$3,500 depending on the time required to complete the mineral search.
