 - g) Attended and answered questions at the July 24th Council meeting in reference to a possible trade of FEDC properties for "no charge" FEDC office rent, in current location, for 8 years-4 months. Purpose was to understand what terms Council wanted in an agreement before bringing to FEDC Board.

- h) Attended a Workforce Dev elopement Summit Conference in Sequin for economic development through agencies like Alamo College, UTSA Rural Development and Texas Workforce Commission.
- Attended a public meeting with City Council and reviewed the 2008 bond situation. There is no planned change/refinance to the 2008 bond which FEDC makes a partial payment.
- j) On August 7th, met with IC2 (UT-Austin) director to better understand their program of identifying and supporting rural entrepreneurial projects within the 14 counties identified as the Eagle Ford Shale Region (Wilson County being one).
