### **New Business:**

**5. Discussion and Possible Action Item:**

Suggested additional requirement of the Façade Grant Policy and Application by Board member Jay Pullin. Additional language: "Each applicant must be current on all city taxes and must not also be receiving funding from some other government entity for their improvements and/or construction. The application will require the applicant to attest to these stipulations before any funding is provided".

**6. Discussion and Possible Action Item:**

**In the 2015-2016 budget amendment with \$10,350 for an Entrance Sign Account, Rancho Grande Industrial Park. Project approved by Board on 09/14. Project underway.**

**7. Discussion and Possible Action Item:**

**In the 2015-2016 budget amendment with \$49,286.10 for a Street Construction-Capital Outlay Account, Rancho Grande Industrial Park, to pay the retainage balance of \$49,286.10 due under the D & D Paving Contract.**

**8. Discussion and Possible Action Item:**

**In the 2015-2016 budget amendment with \$10,000 for a Drainage Ditch Clearing Account, Rancho Grande Industrial Park. Will secure 3<sup>rd</sup> bid and Board approval during October/November. With 2 bids submitted, lowest bid to date is \$9,800; the other is \$14,200.**

**9. Discussion and Possible Action Item:**

**In the 2015-2016 budget amendment with \$8,500 for a Concrete Driveway to Mailboxes Account, Rancho Grande Industrial Park. Will secure 3<sup>rd</sup> bid and Board approval during October/November. With 2 bids submitted, lowest bid to date is \$8,050; the other is \$10,772.**

**10. Discussion Item:**

The City Council rejected the FEDC budget for 2015-2016 because of two items:

1. Executive Director's Salary increase in the approved budget was 5%. Council limited any salary increases to 4.5% for City employees. Since the FEDC Board voted the ED a 3% raise, the Council objection goes away.
2. The second objection, by Council, is the \$50,000 funded in Parks account. Council wants the FEDC to fund the Parks account with \$90,000.

**11. Discussion and Possible Action Item:**

Possible budget amendment to the 2015-2016 FEDC budget, Parks account, with funding of \$90,000.
