**BEING** A 53.87 acre, or 2,346,697 square feet more or less, tract of land out of a 64.362 acre tract and a called 51.977 acre tract conveyed to M.M. Hughes by Deeds respectively recorded in Volume 762, Pages 606-607 and Volume 351, Pages 142-144 of the Official Public Records of Wilson County, Texas, out of the S & J Arocha Grant, A-1, in Wilson County, Texas.
