11/30: ED received a call from the President of Toyado, S. A., plant confirming that the company is still interested in purchasing one of two 11.883 acre tracts in the Industrial Park for warehousing and injection molding and painting plastic auto parts. In September 2017, the FEDC verbally offered the 11.883 acres for \$10,000/acre and Toyoda finance and build their driveway across the 60' drainage easement from West Cardinal Road to their property line running parallel to West Cardinal. After the first of the year, 2018,

Toyado should be offering a written contract on the 11.883 acres in the Industrial Park.

Colin Nichols, Director of Corporate College, Alamo College is here tonight to explain and answer questions concerning skills training possibilities, here in Floresville, and specifically welding training for Non-Veteran and specific Veterans starting January 15th. The Board may also discuss establishing a FEDC Matching Grant for Skills Training for Non-Veteran students with an initial annual limit of \$14,875 (35 students X \$425/ea.=\$14,875); effective January 15, 2018. The 2017-2018 approved budget has \$50,000 budgeted for "New Business Development" or a new line item budget entry can be set-up as "Skills Training Grants" with Board and Council approval.
