- 8. Executive Officer's Report:
 - Activities for the Month are listed below. To minimize the meeting time, the ED will not verbally review the list but will answer specific questions from the Board:
 - ❖ ED is working with a San Antonio engraving company to add engraved Veteran bricks to the Veteran Memorial, next to City Hall. I am working with the City to have blank brick orders at the Utility payment office where the orders will be received and money collected. The brick orders will be sent to the engraving company along with a check. There is no expense to the FEDC. Individuals will pre-pay at a cost per brick of \$50/\$40/\$30 depending on total order size. ED has called individuals on a waiting to notify them of the brick order process. Once the orders and money are received, the engraving company will come to the Veteran Memorial where blank bricks on the Monument will be individually etched. On May 8th, the City, etching company and ED met to finalize the process.
 - ❖ ED called a meeting with the Chamber President and City Manager (as the Christmas Decorating Committee) to discuss options for Christmas Decorating in downtown. ED suggested that the downtown owners/merchants enter a store front decorating contest with monetary prizes of (\$500/\$350/\$200/\$100) to gain support for the contest. The committee is getting bids from 3rd party Christmas Decorating

Companies for a professional, attractive main decoration to be placed next to the Peanut on the corner of the Court House Square. In addition, the merchants decorating contest will be headed by the Chamber along downtown streets. On November 30, the downtown merchants plan to stay open later that evening for holiday shopping. The Board will be updated as further details come forward. It is proposed that Danny Tejada be one of the contest judges and he can choose another judge, of his choice.

- ❖ ED met with the potential buyer of the shopping center containing Anytime Fitness, State Farm Insurance, CATO and Dollar Tree. ED supplied him with our Retail Gap Analysis, Traffic Count study, Retail Trade Area and demographics. I reminded the buyer of the need for a variety of food venders in Floresville. The buyer called later and said he was considering creating pads for a variety of Food Trucks and a children's play area in the vacant, grass area between Dollar Tree and the Car Wash, next door.
- **❖** Attended a meeting with the City Manager and a 3rd party municipal consultant/lobbyist to review their services for the City and FEDC.
- ❖ Attended a lunch meeting with Monty Small, Wilson Community Health Center to discuss building plans covering lots in the Veterans Business Park. The clinic wants to locate on Lots 4 and 5 and the remainder of Lot 2 will be used for staff parking.
- **❖** ED supplied board treasurer with a 1st draft of 2018-19 budget with written assumptions by the ED.
- ED met with City Manager, Ray Lamberth and Ben Reed to discuss punch list items for Sports Complex, Phase I.
- ED, City Manager, Ray Lamberth and Ben Reed met with Linda Zidek, WCN, and discussed Linda's presentation to the board in the May 14th meeting. The WCN service is a Go Wilson app, for \$300/month, that could feature FEDC promotions.
