RESOLUTION NO. 2024-029

A RESOLUTION DECLARING THE RESULTS OF THE GENERAL MUNICIPAL ELECTION HELD IN THE CITY OF FLORESVILLE, ON May 4, 2024

WHEREAS, the City Council of the City of Floresville, Texas has heretofore called for a General Election to be held in said City on May 4, 2024, to elect Two (2) City Council Members and One (1) Mayor hereinafter stated; and

WHEREAS, said City Council has investigated all matters pertaining to said election, including the ordering, giving notice, appointing of officers, holding and making returns of said election; and, the election officers who held said election have duly made the returns of the result thereof, and said returns have been duly delivered to said City Council; and

WHEREAS there came to be considered the return of an election held on the 4th day of May 2024, for the purpose of electing the herein after named officials, and it is appearing from said returns, duly and legally made, that there were cast at said election 1,208 valid and legal votes; that each of the candidates in said election received the following votes:

WHEREAS that said election was duly called, that said notice of election was given in accordance with law, and the election was held in accordance with law; and that

- a) Gloria Morales Cantu was elected Mayor; and
- b) Marissa Ximenez was elected Council Member Place One (1); and
- c) Mario Morones was elected Council Member Place Two (2).

WHEREAS, said above named parties are hereby declared duly elected to said respective offices, subject to the taking of their oaths as provided by laws of the State of Texas; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FLORESVILLE, TEXAS, THAT:

Section 1. The City Council finds that said election was in all respects legally held in accordance with the laws of the State of Texas and the Charter and the Ordinances of the City of Floresville.

Section 2. The City Council officially finds, determines and declares the results of said election be that the following persons were duly elected: as Mayor –Gloria Morales Cantu, Council Place 1 – Marissa Ximenez; Council Place 2 – Mario Morones.


Section 3. It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public as required by law.
