- B. **Downtown Market update**
Krista Scott was not in attendance. Update given by Charlotte X. Nelson. June Market had 46 vendors at the Beer Warehouse, July event had 107 vendors, September Market will be held at the Event Center. June's foot traffic about 500 people attended. July foot traffic was in excess of 2000. FB Vendor Group 514 FB Followers 3,700. Sponsored free movies and Arcadia, Contributed to Hill Country Flood Relief fund. \$500 to the local food pantry. Working on the 2026 schedule. Seeking 3-4 volunteers for the future market.
