The FEDC board approved to pledge \$125,000.00 per year for 20 years starting in FY 2013 for the enhancement and or expansion of sports facilities to benefit the youth of the community. The FEDC will not own the debt but rather pay the amount pledged to the city as required on an annual basis for the debt service. (The impact on the FEDC budget would be seen in FY13. If revenue projections hold true and we expect them to do so, the FEDC would have the capacity to provide this support.)
